## Legislative Update

The 2007 legislative year is off to a fast start, with nearly 100 introductions of uniform and model acts already posted. The Uniform Anatomical Gift Act leads all acts with 9 introductions, but the Uniform Prudent Management of Institutional Funds Act is not far behind, with 8 introductions. The Uniform Environmental Covenants Act and the Uniform Real Property Electronic Recording Act each have 6 introductions. This is just the beginning of what we expect will be a very busy and productive year in the legislatures.
